Hook on, Chica!

For her anniversary, she entered a 100-mile bike race. Boy, did the things she learn in AA pay off!

My journey in AA has been a series of lessons. Lessons of growth through hardships and triumphs. My sponsor always used to tell me that in order to continue to learn and grow in recovery, I'd need to challenge myself to learn new things. So several years ago I picked up cycling as a new hobby. I began by riding every weekend, always learning more about the sport.

After a few years of riding, I saw an ad about a race that would take place near my town. I took this as a challenge. So I signed up for the race that, ironically, would take place right on my sobriety anniversary. To me, it felt like a "sign" that I should accomplish this 100-mile ride on the anniversary of my 24th year of being sober.

I started training. I used the basic skills I had learned in AA to ask for help and to be teachable. I signed up for classes and workshops on the "art" of cycling. I learned how to signal my fellow riders if I were slowing down and how to alert my fellow riders about obstacles on the course. I learned a lot in each class and workshop. Then finally the day of the big race came.

AA had taught me to stand in my truth and to be proud, but as I stood there with 2000 other riders waiting for the race to begin, I suddenly felt alone and somewhat intimidated by all the fancy bikes and gear of the other riders. My bike didn't look as good, my gear wasn't as fancy and I was riding alone.

As I heard the signal for the race to start, I stepped onto my bike pedal with my brandnew sneakers, and I was off! Five miles into the race, I felt better. Other riders were very nice as they passed me. After 15 miles I was starting to feel a little tired, but I had trained for this, and I knew I'd be OK. I thought about my sobriety and how lucky I was to be able to ride with all these amazing people. Thirty miles into the race, I began to feel more tired, but I knew this would be a challenge. Anything worth the effort is going to be a challenge, right?

Resting briefly at 45 miles, I began to get exhausted. Forty-five miles of sun, wind and hills pushing against my body. I wondered if I really was going to make it. As I began pedaling again, I remembered my sponsor telling me to draw strength from my Higher Power, so I prayed for that strength. During my months of training, I had heard of a riding strategy called "drafting." NASCAR drivers sometimes use it, but I had never tried it. As I approached a hill, I began chanting to myself "anything hard is worth it." I just wanted to make it to the finish line, but that was still more than 15 miles away. I took a



deep breath and asked for God's help as a group of cyclists approached me on my left. They all seemed so at ease, as if the sun, wind and hills were not at all difficult.

As the last rider began to pass me, she motioned to me. I saw her shining blond hair and a big smile on her face as she said, "Hook on, chica." Just then, it finally dawned on me...this is it! She was telling me to ride behind her to stay in her draft. As I slid in behind her, I felt the reduced drag of the air helping to carry me along. I continued on the trail of this train of cyclists and felt my tensions ease and my heart get lighter. When I approached the finish line, tears streamed down my face and I realized this race was like my journey in recovery.

I came into AA believing that for anything to be "worth it" it had to be hard. But the men and women of AA wrapped their arms around me saying, "Hook on, chica!" We don't have to do recovery alone. Recovery doesn't have to be painful and difficult. We can join those who have gone before us and "hook on."

The 2021 Virtual Day of Sharing, held on December 7,2021 and **hosted by the AA General Service Office**, brought together 11 recovery fellowships (including Alcoholics Anonymous) to discuss matters of common interest and collective experience. The first Day of Sharing took place in 1991, and there have been several since attended by representatives of Al-Anon and the National Council on Alcoholism and Drug Dependence (NCADD), as well as a "Fellowship Day of Sharing" in 2008 that included attendees from Debtors Anonymous (D.A.), Overeaters Anonymous (O.A.) and Narcotics Anonymous (N.A.). This was the first Day of Sharing held since December 2019 (after which the pandemic intervened) and was the first ever held virtually.

G.S.O. General Manager Bob W. kicked off the meeting of like-minded organizations by talking about the importance of cooperation between Twelve Step fellowships and how inspiring he found it to be. "We all share these principles," he said. "Each one of these organizations has its own singleness of purpose and we all have the spiritual foundation of anonymity."

The meeting was organized and chaired by Craig W., staff member on the Group Services desk. Part of Craig's work involves cooperating throughout the year with other Twelve-Step fellowships,

answering queries, and sharing information. He calls the Day of Sharing "one of the best experiences I've had in A.A. One member to another, sharing what our organizations are, what they do and don't do. It was so powerful to learn how much we have in common." The 2021 Virtual Day of Sharing was the largest ever held (see box), with


