

Not a river in Egypt

Even in sobriety, denial ruled his life. But Step Six and a cool Higher Power helped him begin to accept reality and lift his head out of the sand "Your daughter has something in her lung," the doctor said. "She needs to have it removed and it needs to be today." My daughter was 18 months old when she inhaled a popcorn seed deep into her left lung. It was a big deal and had to be surgically removed. When the doctor used words like "probability of death" and said, "She could incur permanent damage," well, let's just say that I handled the news like I usually handle anything that scares me.

"This doctor is nuts," I said to my wife. "We should get a second opinion." And some vodka, I thought to myself.

Denial. We all live with it. It's the first of the five stages of grief. Denial not only presents itself in my life when someone dies, but whenever anything happens that involves having to accept any kind of change that scares me. I go into denial at work, over finances, with my kids, my wife, my sponsor. Doesn't matter. If something is about to happen and I don't want it to happen, then it didn't happen. Denial is one of my defects of character. It is the first aggressive angle I take to say no to reality. As an alcoholic, I use denial as a weapon because I really, really want things to go on as they were. People tend to retreat when I get snide and cocky. I'm really good at it and I'm even better at it when I'm hammered. When it came to my drinking, my denial was unbreakable. There wasn't a spouse, a parent, a therapist, a friend or a religion that could convince me that I had a problem. And even when alcohol stopped working for me physically, mentally, spiritually and socially, I still wanted it in my life. That's how powerful the obsession was for me. I did not want to stop drinking.

So when I got to AA and accidentally got a sponsor, I did what any upstanding drunk would do when it came to Step One: I faked it. "Oh, yes. I am an alcoholic," I said. "I am powerless over alcohol. Sure, my life is unmanageable." I'm ready for Step Two, suckers! But as I faked it, even though I was staying sober, my life got worse. My wife asked for a divorce after I got sober; my relationship with my kids broke after I got sober; I saw my financial situation failing after I got sober; I realized I had no friends after ... shall I go on? My life really was unmanageable. It's amazing what a few weeks of "undrunkness" will show a person. I was in serious denial over all of it.

I have said in meetings many, many times: the only thing that alcohol has ever given me was the gift of desperation. Desperation drove me to try a couple of new things that were foreign to me—honesty and God. I was terrible at honesty when I got to AA. I lied and distorted everything for personal gain and to avoid confrontation. Even when I could tell the

truth, I lied. Just a little tweak here and a little fake there and I looked like an even bigger hero, or a much more generous person, or a martyr or just an all-around great guy.

It took a lot for me to go to a meeting and finally admit that I used alcohol to fix my life and that I didn't want to stop, that I was scared, unhappy and alone. But from that moment on, my life has not been the same. That was my first lesson in true acceptance, and it is acceptance that eventually overcomes denial in my life. I don't have to be OK with a situation that develops. I just have to stop denying that the situation is there. If I work an honest program, acceptance soon follows.

I did get to make one choice as an alcoholic. I got to pick a cool Higher Power, and that Higher Power will exist as long as I try to give him my life and connect with him every single day.

Every now and then, the old version of me pops in for a sneak attack, but it only takes over temporarily, thanks to the Steps and all the other resources that AA has given me: meetings, a good sponsor, literature, good conversation with other alcoholics and some service work equals acceptance. It is all wrapped up in the power of my God.

I pray for the newcomer and for anyone who is starting over in this program to get a good sponsor to take them through honest Step work, so that they can ultimately seek and find a Higher Power to manage their daily lives.

God was there for my daughter during her surgery. Even though I didn't know him very well at the time, he was there. He was always around, actually. With the help of AA, I can see him in my life now and it is amazing.

For today, I feel that AA is and always will be a part of my life. God willing, I'm not in denial about that.

District One Meeting Minutes for November 11th, 2025

OPENING:

Mike R. called the meeting to order at 7:00 with a moment of silence, followed by the Serenity Prayer. The GSR Preamble was read by Bryn B. followed by the 12 Traditions read by Mike L. New GSRs Josh for the Keep it simple group, Jenny alternate GSR for the Keystone Saturday group and Rober N. for the Huntsville group were recognized. Heather C. and Elliot R. were recognized as interested A.A.s. Roll call and the contributions basket were passed around at this time. Sam P. presented the October Meeting Minutes, which were reviewed and a motion to accept was raised by Bryan B. then seconded by Thomas C. The district body voted to accept the meeting minutes.

REPORTS

- Corrections - Bob Y. stated that the corrections committee is looking to create an Anonymous hotline for members in the jail to call when they need to talk with an A.A. The Everything A.A. pamphlet is being distributed within the Weber County Jail and Bob is looking to gather a committee meeting sometime soon.
- Grapevine - Patrick F. has been pitching the grapevine to several meetings within district 1. He highlighted the Grapevines weekly podcast "Half-hour Variety Hour" which is now in its 5th year. Patrick also reminded the meeting not to throw out your old Grapevine issues, but instead donate them to your homegroup. It was also advised that a current 1 year physical subscription to the Grapevine is \$35.
- Treatment - Matt A. Announced that he is working on creating a list of treatment centers in our district with contact numbers and a list of insurances accepted by each.
- Ogden Intergroup - Mike L. gave a report listing the number of in person visits, website hits, and a treasury report. He also advised that Central Office Ogden will be closed on November 21, 22, and 27th.
- Logan Intergroup - Mike A. gave a report and announced the Logan Intergroup Gratitude dinner which will take place on November 15th at the Whittier Center.
- Treasurer - Judy Y. gave the September Treasury report. It was asked if the bank can accept Zelle payments for online transactions and Judy will be checking on this. It was also advised that the P.I. and Corrections chairs had yet to be updated on the report and will be in December.

③DCM and DCMC Reports

- DCM Mike R. - Gave a report on the meetings he's been attending and that he attended the Area 69 Fall Workshop as well as attended the DCM planning meeting.
- DCM Shari R. - Attended several meetings in the area and spoke with those in charge about service. Attended the Fall Workshop in Salt Lake City. Takeaways from this include:
 - The bid for the 2026 Fall Workshop was won by District 7, which is the SW corner of Utah and includes places like Cedar City, Panguitch and Kanab.
 - The name of the February Committee Meeting has now been changed to the Agenda Items Meeting and will be hosted the 2 nd Saturday of March vs the 4 th Saturday of February. This will need to be updated in our guidelines.
 - There is a flyer for the Area 69 Committee Meeting which will be hosted by District 7 and held in Cedar City, on December 6 th . On odd years, Area Inventory is addressed during this session. Even years is "Pass the Gavel".
 - Motions presented were:
 - To create a new service position for a Young People in AA chair on the Area 69 Committee.
 - There was a motion presented and voted on to defray our area alternate delegate to attend an upcoming assembly. I forgot which one. It was put forth and passed.
 - The Area 69 budget for travel defrayment for officers was increased due to higher than normal travel and further travel engagements. It was voted on and passed.
 - Reminder that GSRs have a vote in area business and if you'd like your group's voice to be heard, please consider attending these events.
 - Attended the District DCM meeting. The general theme of this meeting was a reminder that our District meetings belong to the GSRs and are for the GSRs. How can we elicit more participation and involvement? What would the GSRs like to have done differently?
 - Announced the A.C.T Alumni Annual Christmas Party, which will be held Dec 13th.

GSR OPEN DISCUSSION

- Mike R. requested a few reports from GSRs about the status and health of their groups.
- Carrie W. from the Treamonton group advised that they had a great Trunk or Treat event where they also passed out literature as well as candy. They are also working with intergroup to get literature on mental health to their local treatment facilities.
- Kyle B. from the Brigerland group advised that their evening meetings are being standardized to a 7pm start time. Their overall attendance is also on the rise at all meetings as the season shifts.
- Bob from the Friday Night Action group advised their attendance is also up and that their meeting is a great place to interact and share with newcomers and young people in A.A.
- Carol G. from the Sisters in Sobriety group advised that she will be shifting from GSR to Alternate GSR and that the group is currently struggling to find leaders. They are regularly attended by a group of ladies from a treatment facility.

The meeting would like to invite treatment centers in our area to visit and invited a discussion on how to approach this without crossing the lines of promoting the program.

Traditions Checklist

The following questions * were originally published in Grapevine in conjunction with a series of articles on the Twelve Traditions that ran from November 1969 to September 1971. While they were **originally intended as suggestions for individual use**, many AA groups have since adopted them and use them as a basis for wider discussion.

We will publish these checklist questions for one of the Twelve Traditions each month in 2025. (Hard copies are available at Ogden Central Office)

(*revised November 2018)

Tradition Twelve:

Anonymity is the spiritual foundation of all our traditions, ever reminding us to place principles before personalities.

1. Why is it a good idea for me to place the common welfare of all AA members before individual welfare? What would happen to me if AA as a whole disappeared?
2. When I do not trust or agree with AA's current servants, who do I wish had the authority to straighten them out?
3. In my opinions of and remarks about other AAs, do I imply that membership requirements go beyond the desire to stay sober?
4. Have I a personal responsibility to help an AA group fulfill its primary purpose? What is my part?
5. Do I do all I can do to support AA financially?
6. Should I keep my AA membership a secret, or reveal it in private conversation when that may help another alcoholic (and therefore me)? Is my brand of AA attractive so that other drunks might want it?
7. What does anonymity mean to me?
8. In light of increased awareness of alcoholism and AA's program of recovery among the general public, why is the principle of anonymity still important?
9. Am I mindful to respect the anonymity of other AA members who may work in my place of employment or my industry? How about AA members who live in my area or neighborhood?
10. What does "principles before personalities" mean to me??


